

## STELLAR APPOINTS MR J. FRANÇOIS LALONDE AS COO OF THE COMPANY

**Montreal, June 4, 2013 -** Mr. Maurice Giroux, President and Chief Executive Officer of **Stellar AfricaGold Inc. (TSX-V:SPX)** ("Stellar" or the "Company") and a Qualified Person as defined in NI 43-101, is pleased to announce the appointment of Mr. J. François Lalonde, P.Eng (BSc. Civil Engineering) as Chief Operation Officer (COO) of the "Company".

Mr. Lalonde has been a Board Member of "Stellar" for over 2 years and has played an important role in the acquisition of the Company's Namarana property in the Republic of Mali.

François Lalonde's main responsibility will be the promotion and the valuation the Balandougou property in Guinea. This implies primarily overseeing and finalizing pre-feasibility study and feasibility study for B1 and B3 gold deposits as reported in previous press release.

Mr. Lalonde is also a director of two other companies listed on the TSX-V namely: 'Kanosak Capital Venture Corporation Inc.' (TSX-V: KKV) and 'Atlantic Industrial Minerals Inc.' (TSX-V: ANL.H).

Maurice Giroux, the president and CEO of "Stellar" declares: "I am very pleased that François is stepping up his involvement with the "Company". He is a very dedicated person and has a marked interest and passion for the mining industry. He has a solid experience of West Africa and is entertaining constant relation with many participants of the African mining scene.
